\*Please note that some of the language used in survey questions related to NPM 12 was modified between the 2016/2017 surveys and the 2018 survey. Despite these changes, for Title V purposes, the Maternal and Child Health Bureau decided to combine the data from 2017 and 2018 because the underlying concepts captured by the survey questions were similar across years. The modifications are listed below (Component B “Doctor actively worked with youth” did not change).

COMPONENT A (DOCTOR DISCUSSED SHIFT TO ADULT PROVIDER)

2016, 2017 Have they talked with you about **having this child eventually** see doctors or other health care providers who treat adults?

2018 Have they talked with you about **when this child will need to** see doctors or other health care providers who treat adults?

COMPONENT C (PRIVATE TIME WITH DOCTOR)

2016, 2017 DURING THE PAST 12 MONTHS, did this child see a doctor, nurse, or other health care professional for **sick-child care, well-child check-ups, physical exams, hospitalizations or any other kind of medical care?**

2018 DURING THE PAST 12 MONTHS, did this child see a doctor, nurse, or other health care professional for **medical care (for example, preventive care, sick care, hospitalizations)?**

2016, 2017 At his or her LAST **preventive check-up**, did this child have a chance to speak with a doctor or other health care provider privately, without you or another **adult** in the room?

2018 At his or her LAST **medical care visit**, did this child have a chance to speak with a doctor or other health care provider privately, without you or another **caregiver** in the room?
